

Transfer of shares on which dividend is unpaid/unclaimed to IEPF Account- Unclaimed/unpaid for the year 2008-09

- As per sub-section (6) of section 124 and 125 of the Companies Act 2013 read with IEPF Rules 2016, as amended from time to time all shares in respect of which dividend has not been paid or claimed for seven consecutive years or more shall be transferred by the company in the name of the Fund irrespective of the fact whether the said dividend has been transferred to the Fund or not.
- The Company has identified 29 cases are eligible to be transferred effective 2008-09. We have sent the individual notices to such shareholders and published the Notice in the Newspapers informing them to claim the dividend at the earliest; otherwise their shares will be transferred to the IEPF Account in due course of time.
- The due date of transfer of such cases, unless claimed otherwise is October 31, 2017.
- The Company will announce the Corporate Action and transfer the shares post above date to the IEPF Authority.
- Once, such shares are transferred, shareholders can claim those transferred shares form IEPF Authority by complying the process mentioned therein.
- Please note that no claim shall lie against the Company in respect of unclaimed divided amount or shares, so transferred to IEPF Account pursuant to the Rules
- Necessary disclosures and returns will be filed in due course of time upon transfer of shares to the IEPF Authority
